1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within $L-1+ 15\%$ (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM_No.1 4 2021_PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

1. Generic

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

2. **Generic**

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

4. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

5. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

6. **Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

7. **Service & Support**

The Service Provider is required to have at least 40 % of the required manpower on service provider's payroll for at least one year. Necessary documents relating to such manpower will be uploaded by the bidder for verification of the buyer. Such manpower will be part of total manpower to be provided by the Service Provider in case he gets the contract against this bid.

8. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

9. **Payment**

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

10. **Past Project Experience**

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Manual Additional / Buyer Added Terms and Conditions:

1. The bidder should upload an undertaking on affidavit of Rs. 100/- declaring that the bidder has not been blacklisted by any government agency in any respect. The affidavit should be made after the publication of the bid.
2. Payment of Salaries and Wages : Service Provider is required to pay Salaries/Wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like PF, ESIC etc. as well as the bank statement of payment done to staff. In no case salary/wages payment to the deployed personnel would be correlated with the monthly bill/claim of the contractor, which are to be done/processed (or pending for payment) with the buyer office i.e. if payment of contractor bill/claim is pending with buyer department due to unforeseen circumstances, the contractor will have to make payment of monthly wages to the deployed supporting staff in this office and will not have any right to stop/withheld the salary/wages payment of deployed supporting staff in this office. Infringement for the same will be an adverse actionable cause for the service provider.
3. The bidder should upload copy of ITR for last 3 years, ending on 31st March of the previous Financial Year duly stamped and sealed by the bidder.
4. ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 Certification.
5. There is no employer and employee relationship between the employees of the service provider and this office.
6. Bidder/Applicant should have supplied at least 10 Manpower minimum for 12

months in an Income Tax Office, in Uttar Pradesh. Necessary documents in this regard must be uploaded.

7. The persons engaged should be conversant in their respective fields of work.
8. The persons engaged shall not be below the age of 18 years and they shall not interfere with the duties of the employees of this office.
9. The functional control over the personnel deployed by the Agency will rest with this office.
10. It is mandatory that the service provider should have an office/ branch office in District Agra, Firozabad, Mathura, Hathras for smooth functioning of the contract. The supporting documents for the same should be uploaded by the bidder. Any one of the following shall be treated as proof for the same: -

- a) Commercial electricity bill (recent) in the name of the bidder.
- b) Registration with labour Department / PSARA (in security bid) showing the address
with District Agra, Firozabad, Mathura, Hathras.
- c) TAN/GST registration (issued before the publishing of bid) issued by concerned
Department having address showing in District Agra, Firozabad, Mathura, Hathras.
- d) Registration issued by registrar of Firms and societies have address in District Agra,
Firozabad, Mathura, Hathras.

11. This office may require the service provider to dismiss or remove from the work place, any person or persons, employed by the service provider, who may be i

incompetent or for his/ her/their misconduct and the service provider shall forthwith comply with such requirements. The service provider shall replace immediately any of its personnel, if they are unacceptable to this office because of security risk, incompetence, conflict of interest and breach of confidentiality or improper conduct upon receiving written notice from office.

12. The service provider has to provide photo identity cards to the persons employed by him/her carrying out the work. These cards are to be constantly displayed and their loss be reported immediately.
13. The service provider shall ensure proper conduct of his person in office premises, and enforce prohibition of consumption of alcoholic drinks, any kind of narcotic items, Gutka, any kind of tobacco or tobacco product, paan, smoking etc. and loitering without work.
14. The bidder should have valid character certificate issued by the District Magistrate. (Documentary evidence of the same should be uploaded by the bidder).
15. The bidder should be registered with ESIC & EPF authorities. (Documentary evidence of the same should be uploaded by the bidder).
16. The entire documents should be properly signed and stamped by the bidder.
17. This office reserves the right to amend / withdraw any of the terms and conditions with prior approval of competent authority i.e. Hon'ble Commissioner of Income Tax (DR), ITAT, Agra, in the Tender Document without giving any notice or assigning any reason. If any dispute arises, the decision of Commissioner of Income Tax (DR), ITAT, Agra in this regard shall be final and binding on all.
18. The Worker should wear the uniform, while on duty, prescribed by the Service provider.
19. The Worker should have undergone proper training on all security related issues, should be decent and well behaved.

20. Once the worker has been allotted a spot / site he/she shall remain in the same position till he/she is shifted.
21. The antecedents should have been verified by the Service provider from the local police authorities and the Service provider has to certify the good moral character of each person. The service provider has also to ensure execution of background check as per the SOP norms of CISO instruction 2/2023 of dated 17.03.2022 issued by Central Board of Direct Taxes, New Delhi.
22. The bidder must visit o/o the Commissioner of Income Tax (DR), ITAT, Agra to inspect the venue on the date mentioned in the bid document and submit Pre Bid inspection report (in two copies) in the prescribed proforma to this office and a copy of the same (in original) must be acquired and uploaded by the bidder through Gem Portal. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
